Association Statutes



Name and center of the association

"Article 1- Name of the association: "International Black Sea Solidarity Association

The headquarters of this association is Turkey

The association can open branches inside and outside the country

The purpose of the association is to carry out the work topics and international agreements of the forms that must be maintained by the association to achieve this goal and to ensure its expansion

Article 2- Association "International Solidarity Society of the Black Sea". It was established in order to provide legal information in Turkey for Turkish nationals and other foreign nationals living in Turkey

Topics and forms of work that should be followed by the association

Conducting research to empower and develop your activities

Holding educational activities such as courses, seminars, conferences and panels

Providing all kinds of information, documents, documents and publications necessary to achieve the goal, creating a document center, publishing publications such as newspapers, magazines, books and bulletins in line with its goals in order to announce it

Providing a healthy work environment to achieve the goal, providing all kinds of technical tools and equipment, supplies and stationery.

Carrying out charity collection and accepting donations from inside and outside the country by obtaining the necessary permits

Establishing and operating economic, commercial and industrial institutions in order to provide the income needed to fulfill the goals of the .statute

Opening clubs, creating social and cultural facilities and equipping them in order to benefit and spend the free time of its members.

Holding dinner meetings, concerts, dances, theaters, exhibitions, trips and entertaining events, etc. in order to develop and maintain human relations between members. To organize or enable its members to benefit from such events.

Buying, selling, renting, renting and renting movable and immovable property needed for the activity of the association and creating real rights over immovable property

Establishing a foundation inside and outside the country, establishing a federation or becoming a member of an established federation, if necessary to achieve the goal, establishing facilities that associations can establish by obtaining the necessary permission

Carrying out international activities, membership in associations or organizations abroad and cooperation or cooperation with these organizations

If necessary to achieve the goal, without prejudice to the provisions of Law No. 5072 on the relations of associations and foundations with public institutions and government institutions, to carry out joint projects with public institutions and organizations in the field of issues related to their field of duties. organizations

Establishing a fund to meet the essential needs of the members of the association such as food, clothing, other goods and services and short-term loan needs

Opening branches and representative offices in the places he deems necessary

Creating platforms to achieve a common goal with other associations or foundations, unions and similar non-governmental organizations in areas that are related to the association's goal and are not prohibited by law

Carrying out all kinds of activities in accordance with the general constitution of the association, which has been approved by the Ministry of Internal Affairs of Turkey, is necessary to achieve the goal and has no legal prohibition.
